## 4 . FIRST AID MEASURES FOR ACCIDENTAL

**Minimum/Maximum Storage Temperatures:**

10 to 49 C (50 to 120 F)

Avoid breathing vapors and mists. Avoid direct contact with eyes, or prolonged contact with skin . In cold weather, this product may stratify and freeze. This does not damage the product. If freezing occurs, thaw and remix before using. Frozen material may be thawed in a warm room. Avoid localized overheating. Vent drums while heating. Mix thoroughly to assure homogeneity.

**Storage:**

Store in tightly closed containers. Store in an area that is dry, well-ventilated, away from ignition sources, away from incompatible materials (see Section 10. Stability and Reactivity).
